ΑΘΗΝΑ, 17 Νοεμβρίου 2015

Στις 14 και 15 Οκτωβρίου του 2015, το ΤΕΕ και το **Ελληνικό Τμήμα της UIA**, που είχαν προσκληθεί σχετικά, εκπροσωπήθηκαν από το **Γραμματέα του Ελληνικού Τμήματος Κυριάκο Πιπίνη** στις συνεδριάσεις, συναντήσεις, εκθέσεις και ημερίδες, που αποτέλεσαν μαζί με τα εγκαίνια της Biennale Πολωνικής Αρχιτεκτονικής με θέμα *The Human dimension in Urban Space*, το **πλέγμα των εκδηλώσεων της UIA, που έλαβαν χώρα στην Κρακοβία, στην Πολωνία**, υπό τη διοργάνωση του SARP (Σύλλογος Αρχιτεκτόνων Πολωνίας), του τοπικού Συλλόγου της Κρακοβίας, του Πολωνικού Τμήματος της UIA και του Δήμου της Κρακοβίας.

Πιο συγκεκριμένα ο Κυριάκος Πιπίνης συμμετείχε στη **διάσκεψη των προέδρων των εθνικών τμημάτων της Region II της UIA** (ως εκπρόσωπος της προέδρου Φανής Βαβύλη, που λόγω προβλήματος υγείας δεν μπορούσε να είναι παρούσα), στην **άτυπη συνεδρίαση των μελών του Συμβουλίου της Region II** κατά τη διάρκεια της συνεδρίασης (ως εκπρόσωπος του Νίκου Φιντικάκη, που λόγω ταυτόχρονης υποχρέωσης σε άλλη εκπροσώπηση δεν μπορούσε να είναι παρών) και στην **έκτακτη σύσκεψη των μελών της Επιτροπής Διεθνών Διαγωνισμών UIA-ICC** (ως τακτικό μέλος ο ίδιος).

Η ολόημερη συνεδρίαση της 15ης Οκτωβρίου συντονίστηκε από προεδρείο με chair την Αντιπρόεδρο της UIA για τη Region II **Deniz Incedayi** και μέλη, το γενικό Γραμματέα της UIA **Thomas Vonier**, τον Αντιπρόεδρο της UIA για τη Region I **David Falla**, τον Πρόεδρο του SARP **Mariusz Scislo** και το μέλος του Συμβουλίου της UIA και της ICC **Jerzy Grochulski**. Οι χώρες που εκπροσωπήθηκαν με αντιπροσώπους τους στην περιφερειακή αυτή συνεδρίαση της UIA ήταν η **Πολωνία, η Ελλάδα, η Τουρκία, η Βουλγαρία, η Ουγγαρία, η Ρουμανία, η Σλοβακία, η Λιθουανία, η Εσθονία, η Ρωσία, η Λευκορωσία, το Αζερμπαϊτζάν και ο Λίβανος**. Επίσης συμμετείχαν οι Πολωνοί διευθυντές διεθνών προγραμμάτων της UIA, **Uscinowicz και Chwalibog**, καθώς και βραβευμένοι Πολωνοί αρχιτέκτονες, το έργο των οποίων παρουσιαζόταν ταυτόχρονα στη Biennale της Κρακοβίας.

Ο εκπρόσωπος του Ελληνικού Τμήματος τοποθετήθηκε επίσημα τρεις φορές με ομιλίες, ενώ με παρεμβάσεις συμμετείχε στις συζητήσεις. Στην παρουσίαση του Ελληνικού Τμήματος αναλύθηκε διεξοδικά το σοβαρό πρόβλημα των Ελλήνων Αρχιτεκτόνων, αλλά και των υπόλοιπων Μηχανικών, εξαιτίας της πολύχρονης οικονομικής κρίσης και αυξημένης ανεργίας, ενώ τέθηκε επίσημα στη συνεδρίαση και υιοθετήθηκε το πρόβλημα των προσφύγων από τη Μέση Ανατολή και τις πιθανές θετικές παρεμβάσεις των αρχιτεκτόνων στο θέμα της προσωρινής στέγασης και διαμονής των ανθρώπων, πολλοί από τους οποίους χάνουν τη ζωή

τους στη θάλασσα. Επίσης ανακοινώθηκε και επίσημα από πλευράς ΤΕΕ και Ελληνικού Τμήματος η καταδίκη της βομβιστικής επίθεσης στην Άγκυρα κατά τη διάρκεια του συλλαλητηρίου των επαγγελματικών επιμελητηρίων Τουρκίας και η δήλωση αλληλεγγύης στους Τούρκους συναδέλφους. Κατά τη διάρκεια της ειδικής σύσκεψης για τους Διεθνείς Διαγωνισμούς και μετά την παρουσίαση σχετικής case study από τους Πολωνούς, ο Έλληνας εκπρόσωπος συνόψισε την τρέχουσα κατάσταση στην Ελλάδα σε σχέση με νομοθεσία για τη διοργάνωση διεθνών διαγωνισμών, και τη μεγάλη απόσταση που πρέπει να καλυφθεί νομικά ώστε να είναι συμβατοί με το σύμφωνο UIA-UNESCO. Ως προς τις προσεχείς δράσεις, από πλευράς Ελλάδας, έγινε αναφορά στην παρουσία του Νίκου Φιντικάκη στη Λίμα του Περού στις αρχές Νοεμβρίου και στο συμβούλιο της UIA που θα διεξαχθεί εκεί, στο συνέδριο ICTA 2016 που προγραμματίζεται για το φθινόπωρο του 2016 στη Θεσσαλονίκη και το Φεστιβάλ Αρχιτεκτονικών Σχολών στην Κόρινθο το καλοκαίρι του 2016, ενώ εκτενής αναφορά έγινε για τα Προγράμματα Εργασίας της UIA των Ελλήνων Διευθυντών Ν. Φιντικάκη, Ι. Μιχαήλ και Ι. Μήτσου. Τέλος στα πλαίσια των εκδηλώσεων το Ελληνικό Τμήμα της UIA έδωσε το παρών στα εγκαίνια της Biennale και στα εγκαίνια της θεματικής έκθεσης Parallels.

Παρατίθεται ολόκληρο το κείμενο πρακτικού της συνεδρίασης της 15^{ης} Οκτωβρίου, που συνέταξαν από κοινού οι συμμετέχοντες, και εστάλη σε όλους από την Αντιπρόεδρο Deniz Incedayi.

At the beginning of the meeting, the participants joined the opening of the International Krakow Architecture Biennale (MBA).

Welcome and Introductions

President of SARP, Mariusz SCISLO

UIA Vice President Region II, Deniz INCEDAYI made their welcome speeches. They welcomed the guests, extended their thanks and their best wishes for a successful meeting.

Adoption of the agenda:

The agenda and the minutes of the last Region II Meeting in Zagreb (January 2015) have been adopted as is presented.

Presentation by UIA General Secretary, Thomas VONIER

UIA General Secretary Thomas Vonier summarized the main aims of the UIA and stressed the points in his presentation; unifying the profession, influencing the world and aiming advances in the profession. He emphasized the target of the triennial as a reform in the structure of the UIA in order to be more effective, visible, fruitful and for more effective use of the budget and potentials. He also underlined the important role of the architect and architecture for today's complex issues.

Presentation by UIA Vice President, Region II Deniz INCEDAYI

UIA Vice President, Region II Deniz INCEDAYI remarked in her presentation the items such as; the difficult situation in the Region II and in Turkey, the architects role in that scene to be more supportive, her participations in the events of the UIA in the last term and gave information on the coming and planned events.

Presentation by UIA Vice President, Region I, David FALLA

UIA Vice President Region I, David Falla underlined the importance of the UIA regional activity and stressed the responsibility of the Member Sections in this regard. David Falla shared his ideas concerning the development of UIA Regional projects. Given that the UIA wants to engage the member sections which are currently inactive and encourage absent countries to rejoin UIA, the aim of Region 1 is to encourage the direct involvement and greater involvement of member sections in the Region 1 program. He remarked that the important projects / events of the Region I include; COP 21 in Paris in November 2015 and also gave information about the projects of summer school prepared for Seoul on the theme "*Resilient Cities*". He added that the projects and contributions of the member sections are important as they encourage direct involvement and responsibility of the member sections and use the potential of local support. He added that the idea is also valuable for the collaborative work between the Region I and Region II.

Short presentation of Region II Council Members/Alternates or Representatives:

Jerzy GROCHULSKI (Poland)

UIA Council Member Jerzy GROCHULSKI (Poland) remarked in his presentation the items below:

- o The importance of the reform process in the UIA
- o The role of the architect and architecture for the scope of "excluded", "immigrants", "handicapped" and the "others"
- o The issues of the public space for the contemporary architecture
- o The discussion and problems to be solved on the public procurement and the relation to ICC of the UIA.

- o He also underlined the importance of cooperation between the regional organizations in that frame.

Serban DRAGOS TIGANAS (Romania)

UIA Council Member Region II Serban DRAGOS TIGANAS (Romania), stated in his presentation the items below:

- o Period of re-inventing the UIA, putting together new ideas and content for the UIA and the professional platform.
- o The expectations of the Member Sections from the Council Members and the perception of Member Sections.
- o Ways to distribute the information and ideas using publishing etc. to create a stronger voice
- o Information on the Romania Museum of History waiting to be launched by the Parliament as a UIA Competition
- o Information on the intention of Moldavian Architects to approach and join the UIA, approached by OAR
- o Information on the Conference on Heritage in Bukovina, Romania, gathering architects from Ukraine, Republic of Moldova and Romania

Andrei BOKOV (Russia)

UIA Council Member Region II, Andrei BOKOV (Russia) remarked in his presentation the items below:

- o Information on the Moscow Festival of "Zodchestvo"
- o He remarked the regional meeting in Baku and the Award Program.
- o The fact that the Russia has also the difficulties in architectural arena and waiting for the new law to be accepted.
- o The importance of the UIA in order to be supportive to the professional processes
- o Information on MACA and new organization. President of Azerbaijan Mr Elbay Kasim Zade elected as the new President of MACA.
- o Suggestion of a "Board of Experts" in the UIA will be useful to reach the governments.
- o Mentioned the problem of the architectural schools, issues of qualification and criteria for architectural education.
- o Stressed the financial problems in the context of fees and asked for an improvement process.

Kyriakos PIPINIS (Greece, on behalf of CM Nikos FINTIKAKIS)

Kyriakos PIPINIS (Greece) denoted in his presentation the items below:

- o Stressed the financial crisis in Greece also remarked the big problems and tragedy of immigrants in Turkey, in the Region II, and in Europe.
- o Underlined the role and responsibilities of the architects in that process.
- o Added the importance of the topic of the Krakow Biennale as "*Human Dimension in Urban Space*".
- o Information on Kavala Conference and the important role of architects to reach the society.
- o Role of the WP's in dealing with the issues of the Region II.

Interventions by the UIA Region II Member Sections by the Presidents and/or Representatives:

(in the alphabetical order, starting from the end for this meeting)

General discussion and interventions by the UIA Region II Member Section's PART 1

Vladimir GUSAKOV, Ukraine

He expressed the importance of the maintaining the heritage values.

Described the several reasons for the crisis in the Region II, such as; corruptions, economic crisis, immigration, poverty.

The importance of contribution of the UIA and its WP's. It could be an effective tool for better results in the profession.

Olena OLIYNYK, Ukraine

She underlined the important the 2 topics as education and heritage and proposed a common conference on cultural heritage and values, which can be prepared with the contribution of Region I + II.

Pointed out the role of co-operation between different universities and the revisions of the curriculum of the universities.

Also denoted the role of the Education Commission of UIA in that context.

Deniz İncedayı, on behalf of Eyüp Muhcu, CAT, Turkey

On behalf of the CAT President Eyüp Muhcu, Deniz İncedayı extended the apologizes of CAT. Due to the horrible terror action which took place on 10th October 2015 in Ankara, Turkey the President couldn't join the meeting. The action was also targeting the members of the Chambers of Architects and Engineers and all the civil society. All the participants transmitted their condolences and worries for the terror action.

Juraj HERMANN, Slovakia

He summarized the events of the recent period in Slovakia.

Information of Slovakian Architects Society 25th Year Anniversary and a conference to attract the young architects.

Underlined the support and fight for architectural competitions and for revisions on public procurement as well.

Information on collaboration with V4, participation in the exhibition in karkow and preparations for joining the Biennale in Zagreb next spring.

Shared the information on Bratislava having the presidency of Europa.

Serban TIGANAS, Romania

Seban TIGANAS as the President of OAR mainly remarked the points below:

The importance of the architect's role in the society

Examples about heritage values (in Konstanza from 1930's) and underlined the responsibility of architects towards the society, not only through the buildings but as well in day to day life

Cooperation with the governments on legislation (OAR's aim to be effective)

Revising process and efficiency in economic and social issues

Value of working with communities and with other professions and in rural parts with defined strategies

Dialog with the clients in an informative way and discussing the support of the UIA in that context.

Andrey BOKOV, Russia

Andrey BOKOV as the President of the Union of Russian Architects mainly remarked the points below:

Recent issues in Russia and the Union of Russian Architects

The importance of the visibility of the UIA internationally and especially between the young architects.

To that aim, the ways of publishing some events and results would be supportive. Promote the discussions and different ideas from the world.

Pawel KOBYLANSKI, Poland

He gave information about the SARP and summarized the difficulties of the period such as; financial problems, not being able to continue in ACE due to the financial situation and collaboration with the Chamber of Architects.

SARP is working with the responsibility of different problems such as; climate change, unemployment, refugee crisis, economic crisis etc.

Looking for new innovative approaches.

He asked the participants to prepare a letter of support to Turkey, because of the last terror actions; it has been accepted by the participants and prepared for CAT.

End of the Part 1:

UIA General Secretary Thomas Vonier replied several questions on behalf of the UIA and emphasized that it's important to formulate the expectations and strengthen the communication. The question of "panel of experts" is another item to be dealt for the UIA Board. He added, UIA is promoting the dismissed member sections and create some formulas to have them back in the UIA.

Presentation of the awards for the Young Architects Leonardo Festival in Minsk

The awards of the winners of the Young Architects Leonardo Festival in Minsk have been delivered by Alexander Korbut and Thomas Vonier.

Lunch Break

General discussion and interventions by the UIA Region II Member Section's - PART 2

El Naghi WASSIM, Lebanon

Information and presentation on Oscar Niemeyer fair Park in Tripoli. The important heritage area is not used properly and is in a very bad shape. Therefore, there is an attempt to register the park area under the List of UNESCO World Heritage. He asked for the endorsement of the UIA.

Information on Arch-marathon realized in Beirut in October 2015. Positive impact and high number of participants. The UMAR meeting has been held as well.

Laszlo G. SAROS DLA, Hungary

Extended thanks for the important Biennale in Krakow

Importance of the support of the City of Krakow.

Stressed some important architectural works and areas in Krakow.

Information on the regional organization titled "Carpathian 8"

Information on the Architectural Section of the Hungarian Academy of Art.

AHA members László Mikó and Dénes Patonai gave information about the V4 organization.

They emphasized, that the existing V4 organization is the cooperation of the Associations of the four countries, meanwhile the fresh V4 Foundation is established by individuals.

Kyriakos PIPINIS, Greece

Impacts of the Santorin Volcanic Landscapes Conference

Information on the exhibition of all the awards of the Greek Section.

Information on the Kavala Conference about "How to use the abandoned buildings?"

Preparations for the Balkan Conference in Thessaloniki with the Region II Meeting

Preparations for the Seoul World Congress working on the Euro-Solar Project

Georgy BAKALOV, Bulgaria

Transmitted support of Bulgarian Union to the CAT for the terror actions and against the civil organizations.

Information on FABSР meeting preparations; planning to have the next meeting in Sofia or Batumi or Tbilisi. Set the new structure and secretary of FABSР.

Thanks to UIA for the work of re-habilitation of the system and the structure.

Intention in working on common projects like "Danube River Space" Project.

Alexandre KORBUT, Belarus

Emphasized the difficult period in the region and as well in Belarus.

Trying to continue the positive works for Belarus especially working on popular discussions for the green areas in the city space.

Difficulties between the architects and the authorities and governments.

Information on the Minsk Leonardo Festival 2015, stressed the cooperation between the countries in that context.

Good results to show the society and people what architecture is about and spread the idea of responsible architecture.

Awards for the Young Architects (151 projects from 21 countries) and UIA contribution was very valuable

He noted the membership fees problem and that anew structuring of fees is needed .

BAUA:

Hindreк KESLER, Estonia/BAUA

Information on the Talin Architecture Biennale (self-driven city)

UNESCO Director of Cultural Heritage Mrs. Bokova joined the event and many fruitful lectures have been realized.

Information on a competition of graduation projects of architectural students of Baltic States and organization about the National Museum by September 2016.

Shared his idea about the regions in the UIA and denoted that the regions should be re-defined with the borders of the continents such as; Europe, Asia, Middle East etc.

Remarks about new organizations in Estonia

Ruta LEITANAITE, Lithuania

She gave information on the developments in Lithuania in the recent period.

They will join the "wooden architecture" exhibition next year in Edinburgh and have the preparations.

With an international jury they gave the National Awards for Architecture on 20 th November 2015.

Discussions on the public procurement issue as well in Lithuania.

She emphasized the question "the role of architecture?" Not to be seen in the quality of the buildings, but also of the day to day life quality.

She gave information on the Jury establishment for modernist heritage buildings aiming to register and preserve the modern heritage.

Elbay KASIMZADE (Azerbaijan)

He mentioned the positive developments taking place in Azerbaijan in the field of architecture and urban planning in the last period.
Information on re-construction of cities and new programmes of the government in the field of architecture.
Raised issues related to education and the Bologna process, stressed the importance of the content of the education and the skills to be expected.

Support of the UIA in the process of certification and licensing is crucial. He informed on the National Awards Program held in country for architectural projects.
Emphasized the importance of restructuring the UIA system and expressed dissatisfaction with the fact that his proposals for changes in the UIA election system and Azerbaijan's representation in the electoral processes had not been considered.

Interventions by the Regional Organizations:

FABSR

Georgi Bakalov made explanations about FABSR:

Invitation for a FABSR Meeting in the new year, March/April to be organized in Sofia or Batumi or Tbilisi.

Need of new Secretary for FABSR and Presidency for the next period.

FABSR meeting has to be organized soon in order to continue the work together.

MACA

Elbay Kasimzade (Azerbaijan) has been elected as the new President of MACA.
Information on MACA recent meeting and works.

VISEGRAD 4

VISEGRAD 4 has been a valuable and productive initiative and regional organization. With the Krakow Biennale V4 organized the exhibition of "Parallels" in the exhibition Hall of SARP.

The Council Member Jerzy Grochulski and AHA member Laszlo Milo made explanations on V4 history and works.

As a separate organization the foundation of V4 continues the events, on the other hand being under the UIA, it has to be with the members of the UIA and members of the Member Sections.

Interventions by the regional WP Directors and / or Committee Members

Krzysztof CHWALIBOG, Director of UIA WP "Architecture for All"

Mr K Chwalibog had his presentation on AfA Work Program and summarized the history, the aims and works of the program "Friendly Spaces". He noted that it's not limited with the idea of "accessibility" but as well a broader understanding of friendly design and social responsibility. The Award Friendly Spaces which started in II Region and had the first edition

in 2014 in Durban will be delivered again during the Seoul UIA congress. The invitation to participants is open. The informations would be published on the UIA website.

Jerzy USCINOWICZ, Director of UIA WP "Spiritual Places"

Mr Jerzy Uscinowicz had his presentation including the history and aims of the WP, "Spiritual Places".

Showed many examples from Poland and mentioned the related events such as, seminars and conferences.

Underlined the process of reconversions of the sacred areas and their related analysis and chances in the buildings.

Discussion on Architectural Competitions and System of Public Procurement

Jacek LENART and **Jerzy GROCHULSKI** have made presentations on the public procurement and international competitions frame.

Information on the EU governmental status and bylaws

Information on a model of SARP for electronic process of competitions.

Discussion on 2 stage competitions and limited competitions

Clarifying the reasons and advantages of the system of competitions.

Jerzy GROCHULSKI declared the program based on the new regulations for public procurement.

Explained the EU regulations and EU funds.

Presentation of Architectural Projects
