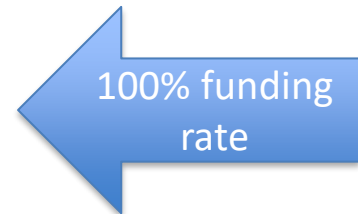

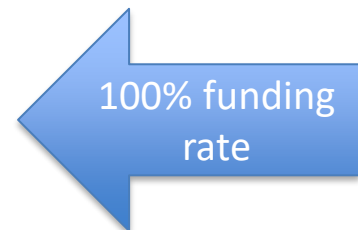

## Rules for Participation and Dissemination

### Participation

- Collaborative projects: at least 3 independent legal entities, with a least **one legal entity from a Member State**
- Restricted participation on strategic importance topics → associated countries maybe excluded

### Main novelties

### IPR & Exploitation


#### Reinforced focus on exploitation

- Obligation to use an online platform (i.e. the **Horizon Results Platform**), if no exploitation of the results takes place after the end of the project (one year after as set out in the HE MGA)
- As default rule, proposals must include a **plan for the exploitation and dissemination of the results** which must be updated during and after the end of the project

### Open Science

#### Mainstreaming Open Science

- Open access to scientific publications maintained and strengthened
- Research data must be handled according to the **FAIR** principles, open access provided under the '**as open as possible, as closed as necessary**' principle and beneficiaries must have a **Data Management Plan**

### › **Coordinator** (beneficiary) – Συνονιστής του έργου

Manages and coordinates the project and will represent the consortium towards the granting authority

### › **Partner** (beneficiary) - Εταίρος

Implements tasks. Can be task leader – Work package leader

### › **Affiliated entities**

Entities with a legal link to one of the beneficiaries above

### › **Associated partners**

Those who carry important tasks but charge no costs to the project.



# Κριτήρια επιλεξιμότητας στον Ορίζοντα Ευρώπη



## Eligibility

### Consortium composition (collaborative projects)

- at least one independent legal entity established in a Member State, and
- at least two other independent legal entities each established either in a different Member State or an Associated Country.

### Gender Equality Plan (applicable only from 2022 on)

Participants that are public bodies, research organisations or higher education establishments from Members States and Associated countries **must have a gender equality plan**, covering minimum process-related requirements.

- A self-declaration will be requested at proposal stage (for all types of participants).
- Included in the entity validation process (based on self-declaration)

## EU COUNTRIES

- Member States (MS) including their outermost regions
- The Overseas Countries and Territories (OCTs) linked to the MS.



## NON-EU COUNTRIES

- Countries associated to Horizon Europe (AC)
- Low and middle income countries: See [HE Programme Guide](#).
- Other countries when announced in the call or exceptionally if their participation is essential



## SPECIFIC CASES

- Affiliated entities established in countries eligible for funding.
- EU bodies
- International organisations (IO):
  - International European research organisations are eligible for funding.
  - Other IO are not eligible (only exceptionally if participation is essential)
  - IO in a MS or AC are eligible for funding for Training and mobility actions and when announced in the call conditions

# Κριτήρια συμμετοχής στον Ορίζοντα Ευρώπη



## Admissibility

### Same general admissibility conditions

- Applications must be submitted before the call deadline, **electronically** via the Funding & Tenders Portal
- Applications must be **complete, readable, accessible and printable**, and include a **plan for the exploitation and dissemination of results**, unless provided otherwise in the specific call conditions.

### Proposal page limit

Substantial reduction in maximum length:

- RIAs and IAs type of actions: limit for a full application is **45 pages**
- CSAs: limit is **30 pages**
- First stage proposals: limit is **10 pages**
- EIC Pathfinder: limit is **17 pages**
- Exceptions, if any, would be specified in the call text.

## Όροι συμμετοχής: Ην. Βασίλειο και Ελβετία

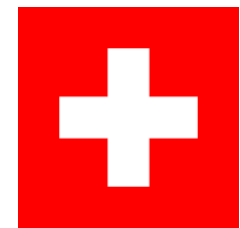


### › **United Kingdom (association pending)**

- Dependent on EU-UK Trade and Cooperation Agreement
- Participates in all parts of Horizon Europe except EIC Fund
- Does **not** count against the **minimum eligibility criteria**
- UKRI (national authority) covers the cost of participation of UK legal entities

### › **Switzerland (not yet associated)**

- No provisional arrangement
- Cannot participate in CSAs with some exceptions
- State Secretariat for Education Research and Innovation (SERI) covers the cost of participation of SWISS entities






## Πώς δομούνται κοινοπραξίες

### Keep in mind that a right partner

- ✓ Could be from Academia, Industry, SMEs, NGOs, etc.
- ✓ Should be committed
- ✓ Should have skills in a **particular field**
- ✓ Should ideally (not obligatory) have previous experience in EU projects/international cooperation projects

### Think about partners within your Consortium

- ✓ **WELL BALANCED:** geographical spread, expertise and type of organisation (Academia, Research centers, Industry, SMEs,...)
- ✓ **RELIABLE**

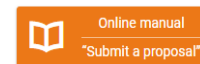

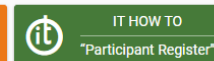
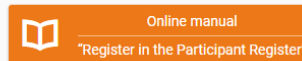

The register contains all participants of EU programmes.
